In order to achieve its mission, the university endeavours to meet the core mandates of teaching, research and community engagement. The university recognizes the contribution of Research and Development (R&D) through research done by both

This Annual research report represents a significant mile stone towards the achievement of our mission statement and vision of being a leading, innovative, relevant and reputable university of Excellency. The Directorate of Research and Postgraduate Studies is a coordinating unit of university research, ensuring quality through the Office of the Quality Assurance Officer and Research Coordinator. The Quality Assurance Office ensures quality of all academic learning programmes and submits them to the Higher Education Authority (HEA) for accreditation. In the year 2020, Mulungushi University had submitted at total number of 85 learning programmes since 2018 when HEA commenced the accreditation process. Out of these, 46 learning degree programmes both undergraduate and postgraduate have been accredited by HEA, the university awaits feedback from HEA for the remainder of the programs.

In terms of research and publications for the year 2020, the university recorded a total number of 71 publications (52 journal articles and 19 Books and Book Chapters) by lecturers and some in coauthored with students in peer reviewed journals both in Africa and abroad. Further, to foster and encourage staff participation in research and generation of new knowledge for national and global development, MU management allocated K420,000.00 as an internal sponsorship for research by academic staff. Seven research proposals were awarded K50,000.00 and a K70,000.00 for a special grant for COVID 19 Research. This was a milestone in the history of the university.

To demonstrate the relevance and innovativeness of the university to the public, the university organised an inaugural conference and launched the Mulungushi University Multidisciplinary Journal. The conference was to commemorate 50 years of Zambia's economic reforms since the Mulungushi economic reforms of 1968 which were held at the Rock of authority, where MU is sited. The theme was "The impact of Socio-economic Reforms on Sustainable development Quo Vadis?" held at Radisson Blu Hotel in Lusaka on 3<sup>rd</sup> and 4<sup>th</sup> December, 2020.

On behalf of MU management, I invite you to read and get insights about research activities taking place at MU in a RARE way in line with the university values.

#### CHAPTER ONE

#### **1.1 Introduction**

Mulungushi University is one of the fast-growing public universities using a self-financing model of operating. As such, research is viewed as key component not only to provide needed solutions to the government and stakeholders as well as to act as a resource base for the University. Our contribution as a university to research is very cardinal as we pride ourselves to be modern in what we do and want to be a market leader in provision of quality research not only in Zambia but also globally. Based on the university mission of providing "High Quality Academic Programmes, Research and Consultancy Services Through Stakeholder Engagement, the university has a vision of being a leading, innovative, relevant and reputable university of Excellency in Africa and globally.

This report provides MU research activities, publications, consultancies and partnerships undertaken during the year 2020. Further, research teams have been created in the six respective schools namely: The School of Agriculture and Natural Resources (SANR), School of Business Studies (SBS), School of Education (SOE), School of Medicine and Health Sciences (SoMHS), School of Social Sciences (SSS); and the School Science, Engineering and Technology (SSET). These groups have been created with the view to encourage team work and mentorship between young academicians and experienced Senior Academicians.

#### 1.2 Mulungushi University Research Grants

For the first time since its establishment, the University through the Directorate of Research and Postgraduate office provided 8 Research Grants of K50,000.00 each to seven (7) groups across different Schools and a special COVID-19 grant of K70,000.00 respectively amounting to a grand total of K420, 000.00.

The projects duration ranges between 6 months and 1 year. This allocation for research grants was done in an effort to encourage members of staff to engage in research proposal writing that will attract funding to academic staff and the University at large. The university, resolved to be having an annual budgetary Research allocation effective 2020. This is in the bid to ensure that members of academic staff remain engaged in innovative research that responds to the developmental needs of society. The University has also been encouraging its members of staff to be competing for externally funded Research projects.

Upon completion of these MU Research grants, it is envisaged that research articles will be published in peer reviewed journals while presentations will be organized internally by the Directorate of Research and Postgraduate Studies for members for staff to communicate their research outputs to other academicians, public audience and other stakeholders.

#### **1.3 Externally Funded Research Grants**

As a university, we also had four Research Grants from institutions which are supporting research on how we can effectively communicate public health and epidemiological information related to COVID-19. In addition, the university is also engaged in developing a mobile application that will track contacts for those individuals who develop COVID-19. Besides, we have also realised that for a nation to develop, it requires to have health people. For example, a team led by Mr. James Mulenga and his colleagues are researching on how best the barriers that exist in people's access to health services in the wake of the established National Health Insurance Scheme can be resolved to that majority of the population especially the marginalised can access basic and specialised health services. Therefore, it's important that as a university we become relevant to this cause and it's important that we report here the school of Agriculture and Natural Resources participation in seeing how as a university and nation become resilient to climate changes in the energy and agriculture sector as this if not well addressed can be detrimental to this sector. Based on the aforementioned, it is evident that the private sector, multilateral organisations are seeing the importance of funding research that is relevant to the needs of society and as MU we will strive to continuously attract funding in this regard. # 1.4 Summary of Research Publications, Book Chapters and Consultancies

Significant effort was made by academic staff to improve on research and publication of articles in international and local peer reviewed journals. Mulungushi University has established Research

Groups in Schools and has also launched the Mulungushi University Multidisciplinary Journal (MUMDJ).

# 1.4.1 Research Publications

During the 2020 academic year, the members of staff had made a total of fifty-two (52) publications in peer reviewed journals broken down as follows: Seven (7) under the School of Social Sciences, ten (10) under the School of Agriculture and Natural Resources, four (4) under the School of Business Studies, nine (9) under the School of Education, eight (8) under the School of Sciences, Engineering and Technology and fourteen (14) under the School of Medicine and Health Sciences as shown in (Table 1).

# 1.4.2 Books and Book Chapters publications

A total of nineteen (19) Books and Book Chapters respectively were published of which seventeen (17) were book chapters awhile two (2) were books published by academic staff from across various disciplines. Some of these books where the chapters have been published (1) include: Trade Policy and Development Book Published by National Board of Trade Sweden; (2) Factors Responsible for Disturbing Peace in Peace Education, (3) Oyster Mushroom Cultivation, (4) Current Trends in Medicine and Medical Research, (5) Cyber Security of Industrial Control Systems in the Future Internet Environment" and Forces and (6) Forms of Doctoral Education in a Newly Configured and Constrained Global Context".

# 1.4.3 Consultancy

In the period under review, academic staff from the university managed to conduct nine (9) consultancies across various disciplines, which included: Nutrition, Water and Sanitation, Health and

Agriculture, Strategic environment assessment, training of Pact Zambia Staff in Data Analysis Using Stata software, training in disaster risk reduction, training in climate resilience in planning and disaster management and climate change in the road sector, and also the COVID-19 survey strategic environment. All these consultancies were carried for clients cutting across i.e., non-governmental organisation, quasi-government institution among others.

#### CHAPTER TWO

#### DIRECTORATE OF RESEARCH AND POSTGRADUATE STUDIES



In line with the vision of the university of being a leading, innovative, relevant and reputable university of excellence, the University aspires to contribute to the body of knowledge through the provision of academic programmes, consultancy and research through stakeholder engagement. Mulungushi University has competent and experienced researchers in the six schools namely; Agriculture and Natural Resources, Business Studies, Science Engineering and Technology, Education; Medicine and Health Sciences; and Social Sciences. Research and consultancy activities are coordinate by the Directorate of Research and Postgraduate Studies.

During the year 2020, the Directorate coordinated the inaugural Mulungushi university internally funded research grants. This was a highly competitive

grant that received 28 proposal from the six schools competing for K420,000.00 grant. A total of seven applicants were successful with each research group being awarded K50,000.00. Additionally, a special grant offer of K70,000.00 was given to a Research team whose proposal was on the impact of COVID 19.

At regional level, the Directorate was awarded a USD 20,000.00 research grant to undertake a study on "Communication of Science and Public Health Information, Epidemiology and Management of COVID-19 in Zambia; Lessons learnt" by the South African, National Research Foundation. This is a (two) 2 year multidisciplinary research consisting of members of staff from various schools in the university.

In order to carryout effective research through quality assurance, the office of Quality Assurance and Research Coordinator have been established with two members of staff appointed respectively. The Directorate is currently working on revising the Mulungushi University Research Policy and development of the Quality Assurance policy. The two documents will be finalized in the first quarter of 2021.

The succeeding chapters will present research, publications, consultancy and partnerships activities from the six schools.

#### CHAPTER THREE

#### SCHOOL OF AGRICULTURE AND NATURAL RESOURCES

The School Agriculture and Natural Resources has a highly competent team of academic and technical staff in the fields of agribusiness, crop science, animal sciences, environment and natural resources management and bee keeping. In academic the school offers both undergraduate and postgraduate programmes including; Agribusiness, Agriculture, Environmental studies at undergraduate level while offering at postgraduate, Agriculture Risk Management, Agribusiness and Climate change and sustainable development are being offered.

To demonstrate the competences in technical skills, SANR has a beekeeping project of producing honey, and being distributed country-

wide in Shoprite outlets. Further, the school has partnerships with several government and private organizations in the country including international institutions is, undoubtedly, bringing a lot of value to the School and the University at large. The school is now working towards the establishment of the Mulungushi University Agribusiness Board to run the university farm. This will be expected expect to demonstrate modern agriculture productivity and contribution to national development. The university farm, will be a center of excellence in many areas of agricultural productivity, including research, teaching, apprenticeship, production, processing and agribusiness.

The School conducted research which was funded by the university as well as from external cooperating partners. In addition, half the lecturers had their articles published in peer reviewed journals which is a good indication.



The School of Social Sciences (SSS) offers programmes at both undergraduate and postgraduate level. The economics and public administration are flagship programmes that equip students with knowledge and skills to effectively contribute to social, institutional and economic development of our Zambia and globally. The School of Social Sciences has three departments namely; Department of Economics, Department of Social Development Studies and Department of Public Administration and International Relations.

In research and consultancy, the school has a team of experienced and competent social scientists undertaking consultancy in, demography, development studies, economics, political and administrative science and social work. In addition, the school in particular the department of economics has entered into partnership with SIDA on a programme in Economic Development Research and Training International Relations and Development. The vision of the school is to become a leading research hub for socio-economic development of Zambia.

Members of staff in the school of Social Sciences were engaged in conducting research in 2020 which was internally funded. Members of Staff in the departments of Economics and Public Administration and Political Studies published in referred journals and book chapters which was a great achievement as this helps document their contributions to the wider subject areas in which they specialized in. As such, other departments like that of social development studies should strive to emulate other departments.

# 9.1 Mulungushi University Multidisciplinary Journal (MUMDJ)

The long awaited inaugural Mulungushi University Multidisciplinary online Journal (MUDJ) was finally launched on 3<sup>rd</sup> December 2020 at Radisson Blu Hotel by the Minister of Higher Education, Hon. Dr. Eng. Brian Mushimba who was represented by Director of University Education in the Ministry of Higher Education, Mr. Charles Mulenga. The MUMDJ is a bi annual journal which will be publishing articles in June and December respectively. During the launch of the online journal, 6 inaugural articles were launched by Director, Mr. Charles Mulenga with support by the Ag. University Librarian Mr. Paul Zulu and Ag. Deputy Vice Chancellor Prof. Douglas Kunda.

#### 9.2 Mulungushi University Inaugural Conference 3-4 December, 2020

The University hosted its inaugural academic conference to commemorate 50 year of the Mulungushi economic reforms which were declared in 1968 at the Mulungushi Rock of Authority, the site where the university is located today. The theme for the conference was "the *Impact of Socio-Economic reforms on Sustainable Development in Zambia: Quo Vadis*". The conference was held on 3-4<sup>th</sup> December, 2021 at Radisson Blu Hotel in Lusaka. It was a blended conference with 34 papers presented. A total of 80 participants including authors attended both online and virtually.

#### 9.3 Quality Assurance

#### 9.3.1 Programme Accreditation
